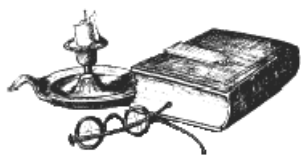
Hi Cheyenne Genealogical and Historical Society members,

## Historical Tidbits

*Dated October 13, 1934*

In his book, "How We built the Union Pacific" General Grenville M. Dodge, chief engineer for the road during its construction, gives a graphic account of how he named the city of Cheyenne.

General Dodge describes how the Union Pacific was forced to exert drastic means to clear up many of the plague spots along the line because of the adventurers and desperate characters who congregated along the line and followed the progress of the railroad construction. How he called in troops from nearby Fort D. A. Russell to clean up Cheyenne in the winter of 1867-68 is told by General Dodge:

..... We had as escort two companies of cavalry and two of infantry under the command of Lt. Col. J. K. Mizner, who had with him Lt. J. W. Wheelan, and Dr. Henry B. Terry, assistant surgeon, U. S. army.

'We started out the first of June and went to the end of the track, which was then at North Platte, then up the Lodge Pole to the east base of the Black Hills, where we were joined by Gen. C. C. Auger, who was then in command of that department with his staff. General Auger's instructions were to locate a military post where I located the end of the division, at the east base of the mountains, and after a thorough examination of the country, I located the division point on Crow Creek, where Cheyenne now stands and named it Cheyenne, and General Auger immediately located just north of the town the military post of D. A. Russell.'

..... regarding the settlement of Cheyenne when the railroad was being built, General Dodge says this:

'In the winter of 1867-68 the end of the track was at Cheyenne. During the winter there had assembled there a very large number of people: Possibly it was the greatest gambling place ever established on the plains, and it was full of desperate characters. The town of Cheyenne we had claimed, laid out and leased the lots to the occupants, and we organized the local government. There was no title to be obtained to the town, but we treated this as all towns, claiming it for the company, laying it out into town lots and not allowing any one to locate there without taking an agreement from us allowing them to occupy it and agreeing to deed it to them when we got title.

'There had been established there by the government Fort D. A. Russell, some two or three miles north of the railroad track and there was in command Gen. J. D. Stevenson, who had served with me during the Civil War. In my absence these desperate characters got together, held a meeting and jumped the town, refusing to recognize the authorities we had put over the town or in any way to comply with our orders.'

'They had commenced robbing our train men and committing other depredations that I knew we must stop or lose control of the railroad forces at the end of the track. I immediately wired General Stevenson, calling his attention to the condition of affairs and asking him to use his troops to bring about order and a recognition of our authority, and while we had no legal right in the matter he turned out his troops as skirmishers and drove every citizen in the town to a mile or so south of the tracks and then held a parley with them.'

'He told them until they were ready to comply with the orders and recognize the authority of the railroad company they should not go back to their property: That really the land belonged to the United States and the railroad was occupying under government charter. This brought them immediately to terms and they immediately made peace, and were allowed to come back to the town and we afterwards had no trouble with them.'

I looked at this site a long time ago and thought "nice idea," but then early this summer I again checked it out and was really excited about what I found. "Findagrave" is going to be my next year's project.

At Findagrave, check out famous people especially Nellie Tayloe Ross and see what has been added to the site. I just knew my German-Russian ancestors buried in Billings, Montana, would not be there along with several others I checked. Guess what! Many were there. What is great about the site is they are not only adding the tombstone picture with typed data, but also they are adding a live picture, a photo of the cemetery, and a history of the person. You can even put a flower on the grave and leave a special memory story with the flower. Check out my ancestor by putting Jacob Kraft (Montana) in the search blanks. I have this photo from years ago and the one on this site is better. Some other good examples are Alpheus Harmon, Nathaniel Harmon, and Mary Alzina Sperry Harmon or any added by Cheryl Bills. Some names are added to cemeteries without pictures with the anticipation of someone adding a photo later.

I now want to add the histories and "live photos" for my family members plus the photos of tombstones. This week while I was in Lusk, Wyoming, I took digital photos of the cemetery name, which is "Lusk Cemetery," along with my husband's ancestors' tombstones, so I want to write histories and add "live photos" of each of them too. People have added one tombstone photo at a time and others have added entire cemeteries. I want to suggest next year our society do this for Lakeview as a project. We could have a picnic while we each take digital photos of a section until we have taken all the

tombstone pictures in the cemetery. I put my name in the site as a person who would be willing to take photos requested by others, and I have had three requests so far for Lakeview Cemetery.

Only a few in my immediate family are a "little interested" in my genealogy passion, and I am wondering what is going to happen to all my photos, data, etc. Findagrave has given me a outlet for all the information that does not fit the new project by the LDS Church, that is in beta testing now, which will include all data, history, photos, videos, documents and mementos for each of our ancestors. (I gave a program on this earlier this year at the library.)
