She was treated by the Streetsboro Fire Department and transported to Robinson Memorial Hospital. After investigating the incident, it was determined that Adam Harris, 21, of Streetsboro, had accidentally discharged a 12 gauge shotgun into the floor of his apartment resulting in the injury to Ms. Shaw. Harris was arrested and charged with Negligent Assault. He was taken to the Portage County Jail.
